The Ewals Fuel Clause is based on the following conditions:

- · The fuel surcharge applies only on standard transport costs (i.e. surcharges for waiting hours, customs clearance are excluded);
- The fuel surcharge mechanism applies on the offered base rates, agreed at the beginning of the contract;
- · The fuel price that was reported last in a certain month, is used as reference for the fuel surcharge of the upcoming month.
- Each month the fuel surcharge is determined by reviewing the last reported fuel price of the previous month vs. the fuel base price.
- · The fuel counts for approximately 30% of the standard transport cost.
- The threshold for fuel change to apply is +/- 5 % in relation to the fuel base price.
- · In case the last reported fuel price of previous month is within +/-5% compared with the fuel base price, the fuel surcharge of the current month will be 0%.
- In the situation that the last reported fuel price of previous month is outside the threshold, the fuel surcharge is determined by multiplying the 25% with the difference between the two fuel prices (last reported week previous month vs. base fuel price). Two examples are shown on the next slide.

^{*} Fuel price is rounded on zero digits.

Example 1

- o Base fuel price = 1.00 EUR
- o Fuel price of January = 1.04 EUR
- o $\,$ The increase is 4% and therefore within the threshold, resulting in fuel surcharge of 0% for the month February.

Example 2

- o Base fuel price = 1.00 EUR
- o Fuel price of February = 1.10 EUR
- o $\,$ The increase is 10% and therefore outside the threshold.
- o The fuel surcharge is 25 % of 10 % = 2,5%* fuel surcharge is applicable on the standard transport cost for the month March.
- * The fuel surcharge is rounded on 1 digit.
